- EMS – Funding for county EMS

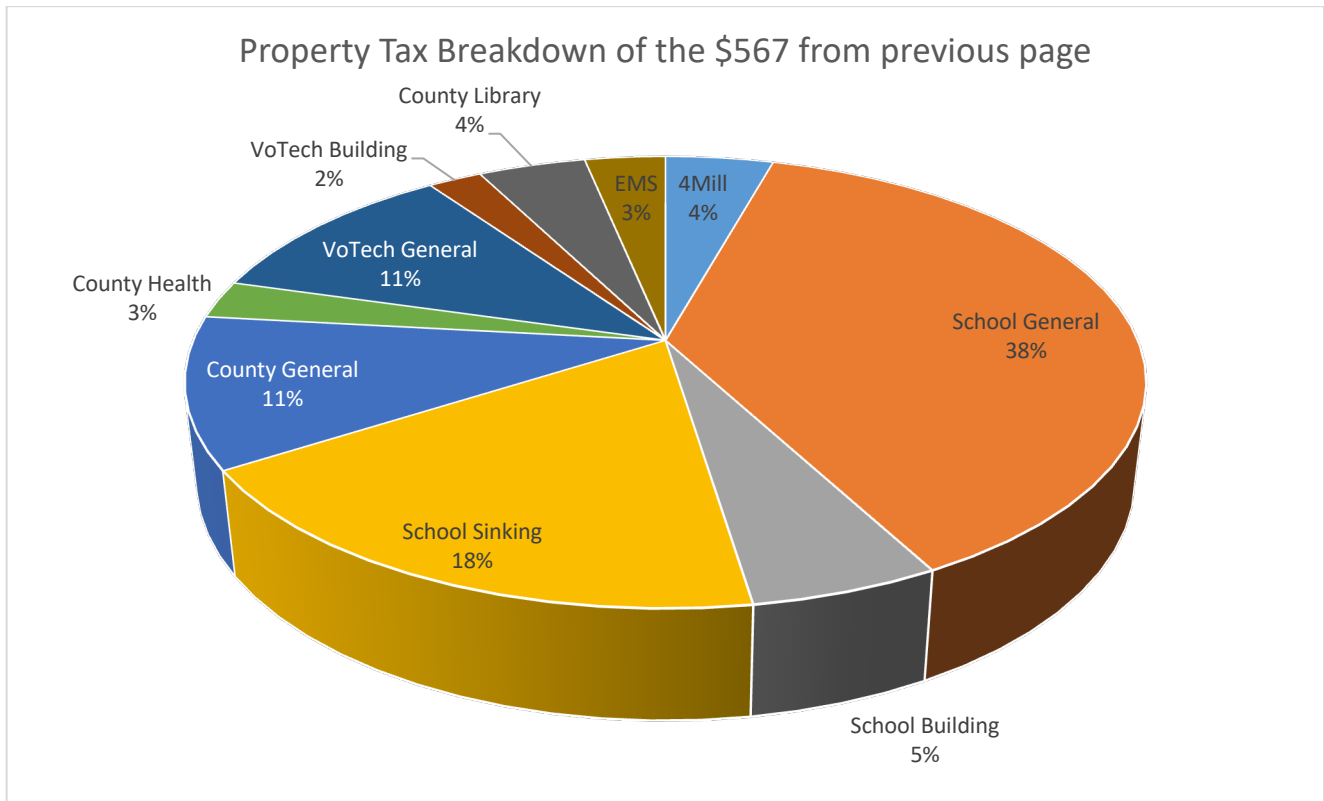

Where does my property tax money go?



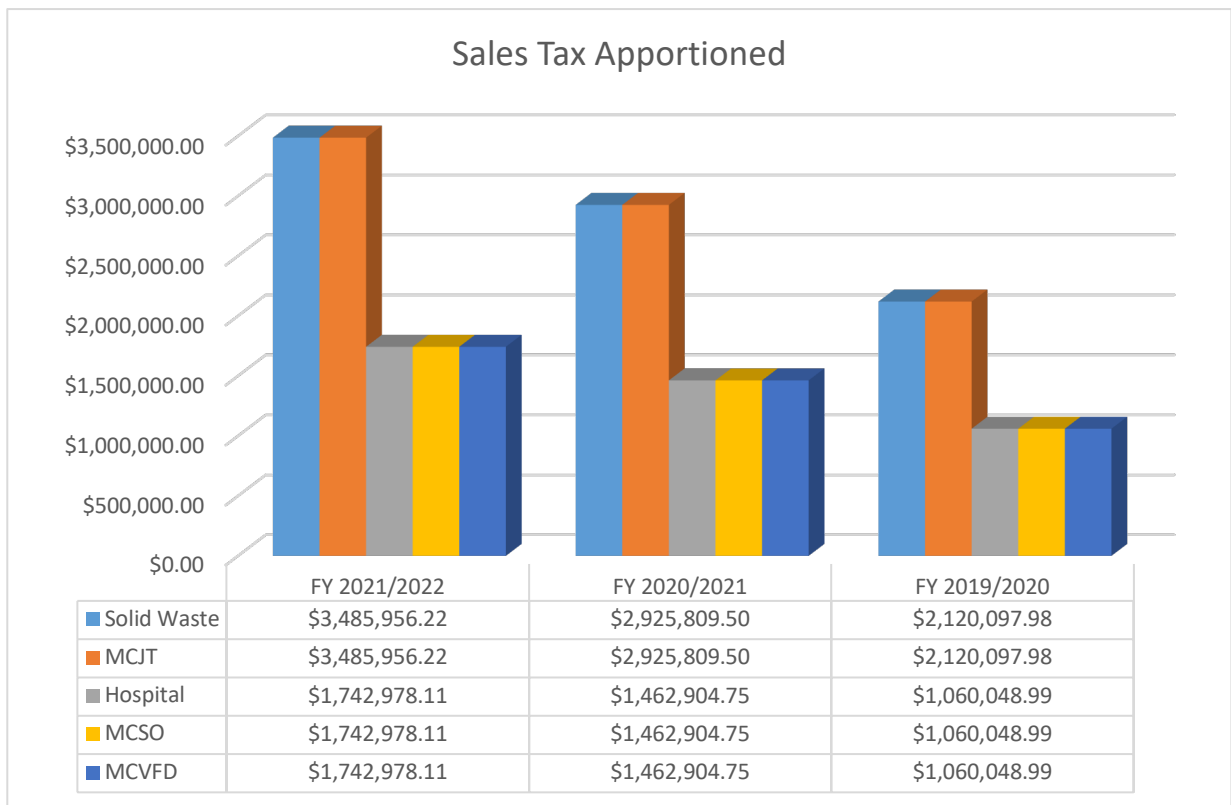

Sales Tax

County sales tax is voted by the public to be split for redistribution by state statute. The county sales tax is collected by the Oklahoma Tax Commission and is redistributed back to the county as specified by the voters.

County Sales Tax is split:

- ½ cent Solid Waste
- ½ cent McCurtain County Jail Trust
- ¼ cent Hospital Authority
- ¼ cent McCurtain County Sheriff's Office
- ¼ cent McCurtain County Volunteer Fire Department



Neither County General or Highway gets sales tax money

Lodging Tax

Lodging Tax is split:

- 5% McCurtain County Fair Board
- 10% McCurtain County General Fund
- 85% McCurtain County Tourism Authority
